We also send our condolences and prayers to the P.O.E.R.'s Attorney John Waddy, Jr.


Attorney Waddy's brother, Novel Waddy died on January 7, 2019.

Bernadine Kennedy P. Kent

Rep. Kent was born and raised in East Chicago, Indiana, a steel mill union city. Her parents, like many African Americans of the time, migrated from the South for better opportunities in the North. Her father could not read or write. Her mother went to the third grade, and yet, they bought a home and raised five children. All children graduated from high school and two went on to graduate from Central State University. Rep. Kent's husband, whose own father was a Tuskegee Airman,

served his country as a Green Beret in Vietnam.

Hers is the living story of the American Dream. First her parents achieved it, despite education barriers, then she did, because of education, and that is what she committed her life to.

For well over 20 years, Bernadine Kennedy Kent lived her passion. First as a teacher and then as an Assistant Principal for Columbus City Schools where in 1999 she was voted educator of the year. Now, she advocates for the rights, protection and safety of children as the Founder of Parent Advocates for Students in Schools (P.A.S.S.).

She is also recognized as an activist and whistleblower. Rep. Kent was instrumental in exposing the data tampering, identity theft, and tutoring fraud in the No Child Left Behind (NCLB) programs. She was recognized by the U.S. Department of Education and the Auditor of State (AOS). The AOS' Chief criminal investigator described her services as useful in providing documented facts and knowledge of the NCLB operations and systems allowing him to evaluate from a factually documented perspective.





Rep. Kent's relentless personal investigation extended over a six year period and resulted in the Auditor of State's announcement in October 2015 that his office, along with the U.S. Attorney's office, had uncovered the NCLB Tutoring Programs fraudulent activities had cost the taxpayers more than \$800,000.

Rep. Kent continues in her advocacy for children relying on documented facts and an understanding of how our local and state agencies operate as well as possessing a clear understanding of the law and how it affects our children and communities at large. She understands the need and fair expectation for people to feel empowered by the laws set in place for them to receive important services, benefits, and protections from the public's government entities.

Further, through her advocacy, a rape case was re-opened and five child victims under the age of 11 received protection from continuing neglect, physical assault and rape in their own home.

Her advocacy for the reported child victims heightened her awareness of the importance of prevention of all forms of child abuse as a factor in increasing the overall safety in our communities reducing the escalating frequency of violent crimes as a whole. Failing to address these issues further increases the potential exposure to and victimization of minors in being vulnerable to recruitment from gangs and being lured into an increasing minor sex trafficking industry in Ohio.

History of the Police Officers For Equal Rights

The Police Officers for Equal Rights was established in 1978 as a result of sixteen Black Columbus Police Officers filing a discrimination lawsuit in the United States Southern District Court regarding promotions, discipline, and assignments and transfers. The lawsuit was heard in March-April of 1984 before United States Southern District Court Judge Robert M. Duncan. In 1985, the City of Columbus Division of Police was found guilty of discrimination.

The Police Officers for Equal Rights was chartered in the State of Ohio in August 1989 as non profit organization. The organization was officially chartered into the Nation Black Police Association and became a member of the Eastern Region in 1990.

President James Moss was awarded Police Officer of the Year Award in 1995 and the Police Officers for Equal Rights was awarded Chapter of the Year Award for their fight against discrimination in the Columbus Police Department by the National Black Police Association Eastern Region.

On March 30, 1995 President James Moss filed an original action in the Ohio Supreme Court contesting the Ohio Revised Code 149.43 (Public Records Law) and on April 20, 1995 the court issued a ruling in favor of James Moss to allow police records open to the public for review and copying. President Moss used this law to get thousands of records from Columbus Police Department to gain access to evidence to file a complaint against the Columbus Police Department with the United States Department of Justice in 1995. After years of taking records to the Washington, On October 21, 1999, The United States of America (U.S. Department of Justice) filed a complaint against the Columbus Police Department of remedy a pattern or practice of conduct by law enforcement officers of the Columbus Division of Police that deprives persons of rights, privileges, or immunities secured or protected by the Constitution or laws of the United States.

In the year 2000, the P.O.E.R. began a petition campaign to get a Racial Profiling Law amended to the Columbus City Charter. Although, the P.O.E.R. collected more than 10,000 signatures, the Franklin County Clerk declared there were not enough of valid registered voters who signed the petition to place the Racial Profiling Law on the 2000 November ballot. The P.O.E.R. attempted two more petition campaigns but they were not successful but it brought the issue of racial profiling to national news and made it a political issue.
